## RULES.

---

1.—That the Society shall be called the "COCHIN CHAMBER OF COMMERCE."

2.—That the object of the Chamber shall be to promote a friendly feeling amongst the Mercantile Community of this Port, to collect and record information on all matters of mercantile interest, more especially in connection with the Malabar Coast, to exert itself in obtaining the removal of all acknowledged grievances, and to advance by all means within its power the common good, to receive reference from, and to arbitrate between, parties willing to abide by the judgment and decision of the Chamber, and to form a Code of practice to simplify and facilitate transactions of business.

3.—That all European firms established not less than three years in Cochin be eligible as Members on payment of entrance fee and on signature of the Rules and Regulations in the manner hereinafter prescribed.

4.—That firms wishing to become Members must be duly proposed, seconded, and balloted or voted for: a majority of two-thirds being requisite for election.

5.—That voting by proxy be not allowed.

6.—That the entrance fee of each firm, or individual shall be Rs.350.

7.—That the Chamber reserves to itself the power of expelling any of its Members, the same to be decided on at a General Meeting by a majority of three-fourths of the Members present.

8.—That the majority of firms constituting the Chamber be deemed sufficient to form any General Meeting, only one Member of each firm to count in voting, although two or more may be present.

9.—That, if in the opinion of a majority of the Members any Member has not conformed to the Regulations of the Chamber, or has been guilty of any conduct likely to reflect detrimentally on the Chamber, such a Member shall be requested to resign and shall thereupon cease to be a Member.

10.—That the affairs and funds of the Chamber shall be managed by a Chairman and a Committee of 3 including an Honorary Secretary. This Committee will report to the Chamber from time to time as required.

11.—That the Chairman and Committee Members be appointed by the Members of the Chamber from among themselves and the Honorary Secretary by Members of the Committee from among themselves.

12.—That the Committee shall meet for the purpose of transacting business at such times as may suit their convenience, but not less often than once a month. The Proceedings at such Meetings shall be recorded in a Minute Book to be kept in the office of the Chamber, and shall be open to the inspection of all Members subject to such Regulations as the Chamber may make with regard thereto.



13.—That a General Meeting of the Chamber shall be held at least once in every year and shall be either ordinary or special and shall be held as may be considered convenient or necessary for the despatch of business.

14.—That an Annual General Meeting shall be held as soon after the completion of the Report referred to in Rule 16, as is practicable.

15.—That the Committee shall be bound to call a General Meeting on receiving a requisition to that effect signed by two firms—all notices of motions to be put forward to be supplied to individual Members three days before the Meeting.

16.—That an Annual Report be drawn up of the Proceedings and, upon being approved of, be printed and circulated.

17.—That all references made to the Chamber for their opinion be subjected to a minimum charge of Rs.20, to be increased at the Chamber's discretion if the Chamber sees right; which amounts are to be carried to the funds of the Chamber.

18.—That all proposals to change Tonnage Scale should be intimated to the Members of the Chamber in writing at least one month before they come up for discussion, and that all notices of Meetings should state the business which is to be transacted thereat.

19.—The above Rules are only to be added to or altered by a majority of the Members of the Chamber.



## SURVEY REPORTS AND ARBITRATION AWARDS.

Whereas it has been represented to the Cochin Chamber of Commerce that it is desirable to give Survey Reports and Arbitration Awards an official character, the following Rules (in which the word "Arbitrator" includes "Surveyor") have been passed by the Chamber for the attainment of that end:—

Rule I.—Certain gentlemen, who have been nominated and unanimously elected by ballot by the Committee of the Chamber, shall be appointed Arbitrators to the said Chamber of Commerce; but the Chamber reserves the right of cancelling the first and all future appointments by a majority of votes of the Committee of the Chamber by ballot.

Rule II.—References to the Chamber may be made—

(1) If ~~by~~ <sup>parties to</sup> a contract state their willingness in writing to abide by the decision of the Arbitrator selected by the Committee from the above list, or subsequent additions thereto.

(2) If one of the parties to a contract state in writing that one of the conditions of the contract is dispute be that a reference lies by him to the Chamber of Commerce.

Rule III.—No Arbitrator shall adjudicate in a matter in which he or his employers are interested, and no two Arbitrators connected with the same firm shall be selected to settle any dispute.

Rule IV.—The Chairman shall select the Arbitrators in rotation from the authorised list, subject to the provisions of Rule III.

Rule V.—One or more Arbitrators shall be appointed for the settlement of each matter under reference, according to the wishes of the person or persons referring the question to the Chamber. In the event of no special number of Arbitrators being agreed to, one only shall be appointed.

Rule VI.—The names of Arbitrators shall not be made known to any persons whatever, except as provided in Rule XVIII.

Rule VII.—The approved list of Arbitrators under these Rules shall be circulated annually, or whenever asked for, to all Members of the Chamber, and shall be supplied to any party applying for the same.

Rule VIII.—Before any Arbitration shall be entertained a deposit of Rs.16 for each Arbitrator, and Rs.16 for an Umpire (in case the number of Arbitrators asked for be an even number), and Rs. 16 for the Chamber of Commerce for *each contract*, together with the value of stamp under Act I of the Indian Stamp Act, 1879, required on the Award, shall be made with the Chairman. Fees not expended will be returned to the depositor.

In cases where neither of the parties to the application shall be Subscribing Members of the Chamber of Commerce, the fees payable shall be double those mentioned in the preceding part of this Rule, and the said enhanced fees shall be divided equally between the Arbitrators and Umpire of the one part and the Chamber of Commerce of the other part.



Rule IX.—As soon as possible after applying for Arbitration under the Chamber's Rules, each of the parties shall submit in writing a statement of the matter in dispute; the original of such statement shall be signed, but for the use of the Arbitrator the parties shall submit an unsigned copy of their statements.

A joint statement may be signed and sent in, but with unsigned copy thereof.

The original contract, or an attested copy, must accompany every reference.

Rule X.—In the event of the Arbitrators not being able to come to a decision by a majority of votes, the Chairman shall request the next Arbitrator on the list to act as Umpire to decide the matter, and his decision shall be final, and need not necessarily agree with that of either of the Arbitrators.

Rule XI.—Arbitrators and Umpires shall have the right to call for such evidence as they may deem necessary, but shall not have the right to take the opinion or assistance of Attorneys or Counsel.

Rule XII.—Arbitrators and Umpires shall, as far as possible, support their Awards by a statement of the reasons upon which the same may be founded.

Rule XIII.—If the seller shall have offered an allowance equal to, or more than, the allowance granted by the Arbitrator, then the whole cost of the Survey or Arbitration shall fall on the buyer. If the buyer have offered to accept an allowance equal to or less than the allowance decided by the Arbitrator, then the whole cost of the Survey or Arbitration shall fall upon the seller. If the Arbitrator awards no allowance, the whole cost of the Arbitration shall fall on the buyer. In all other cases the Award shall state which of the parties to the Arbitration is liable for the payment of the Arbitration fees.

Rule XIV.—All decisions shall be submitted in writing to the Chairman who shall then, without disclosing the names of the Arbitrators, communicate the result to the parties concerned.

Rule XV.—A record of all Arbitrations shall be kept in the office of the Chamber of Commerce, and shall be open at all times to the inspection of Members of the Chamber; but such record shall not disclose the names of the parties concerned in such Arbitrations.

Rule XVI.—Both the parties to an Arbitration shall, on application, be entitled to receive from the Chairman of the Chamber of Commerce a certified copy of the Award under his signature. For each copy of such certificate a fee of Rs.3-8 shall be payable to the Chamber of Commerce.

Rule XVII.—The insertion of a clause is recommended in all contracts made with dealers to the effect that in the event of any dispute, the parties to the contract agree to abide by the decision of an Arbitrator, or Arbitrators, appointed by the Chamber of Commerce under its Rules for Survey Reports and Arbitration Awards; but it is decided that the insertion of such clause is optional, and that Members of the Chamber are in no way bound to submit disputes to Arbitration under these Rules in the absence of such clause in their agreements with dealers.

Rule XVIII.—Should parties to an Arbitration require the attendance of the Arbitrator in a suit pending in the law Courts in which an Award of the Chamber is to be produced in evidence, the Chairman is authorised to give the name of such Arbitrator upon receipt of a requisition by either party stating that it is for that purpose only that the information is desired,

With respect to a steamer or sailing vessel partially discharged which does not return to this Port for cargo on her homeward voyage, the rate shall be 8 annas a ton on every ton discharged, provided the total amount exceeds Rs.100, failing which Rs.100 shall be charged.	
The conversion into Indian currency of sterling freight payable in India shall, unless otherwise stipulated, be made at the rate for Bank Bill on London payable on demand; and the rate ruling at the close of a Mail shall be the rate applicable to such purpose during the subsequent week.	
Brokerage on a forward contract shall be payable on the completion of the transaction.	
That Rs.2 per shipping ton is a fair and legitimate rate of Commission for the receiving and shipping of Merchandise on which there is no charge, but for the simple cost of transshipping.	
That it shall be considered the custom of this port that no return commission is payable on Freight engaged for firms out of Cochin, it being open of course to Agents to make their own arrangements with shippers.	
Two and-a-half per cent. commission on Bills of Lading Freight at par of exchange is payable on shipments by sailing vessel to London, but no such return on shipments to Continent and America nor on cargo per steamers,

## RULES AND REGULATIONS

FOR

### MEASURING CARGO.

**To come into force on the 1st September, 1892.**

---

1. No measurements to be accepted except such as are taken by the Sworn Measurer appointed by the Chamber.
2. A fee—the amount of which shall in no case exceed 3 anna a bale, but which may be regulated by the Chamber from time to time to meet necessary expenses—shall be levied on bales shipped, for which the attendance on the Sworn Measurer has been required.
3. The Measurer shall measure not less than 5 bales in every hundred. In measuring, the callipers are to take in the rope or iron on the one side of bale, and leave it out on the other,— $\frac{1}{4}$ th inch to be given and taken alternately.
4. The Measurer shall give a certificate of measurement which must be produced by the shipper when applying for Bills of Lading.
5. Should any doubt arise as to the bales being of the customary weight (viz., 2 $\frac{1}{4}$  cwt. nett, Coir Yarn ; 200 lbs. nett, Coir Fibre), the Measurer is empowered to weigh any such bales, and in the event of there being any difference in weight separate measurements must be taken.
6. No measurements shall be held good unless such as are taken by callipers bearing the Chamber's stamp.
7. In case of dispute as to measurements, the Master Attendant be requested to measure the disputed package or packages, and his decision shall be considered final ; the party found to be in error shall pay a fee of Rs.15.
8. Measurements are to be taken where Merchandise is stored ready for shipment.
9. The charge for measurement shall be defrayed by the ship.

### Weighing Grain Cargo (inward).

Cargo to be weighed on shore, and unless otherwise specially arranged, each lighter from vessel to call at Custom House and there weigh not less than 10 bags (not selected separately, but in tires or running landing numbers), and the average of such weights on a whole parcel to be taken as the weight for calculating freights. In the event of any lighter failing to stop at Custom House or at any other landing place previously arranged, vessel to have the option of recovering freight on the contents of any such lighter or lighters at Bills of Lading weight.

For Bulk cargoes it is the custom for consignees to send on board empty gunnies for removing cargo and same to be weighed on shore as before-mentioned.

1. In the case of a coasting vessel which calls at a port *in ballast* paying port dues there at three-fourths rate under Section 46 of the Indian Ports Act X of 1889 and enters a second port laden with cargo and passengers taken in at the first port, the difference between the full rate prescribed in the schedule and the ballast rate shall be recovered at the second port.

2. If a foreign vessel trading with Straits Settlements calls at a single port in a group *in ballast* paying port due there at three-fourths rate and re-visits the same port within 60 days laden with cargo or passengers, the difference between the full rate and ballast rate shall be recovered.

3. If a foreign vessel calling at more than one port enters first port *in ballast* and pays port dues at three-fourths rate and re-enters that port within 60 days laden with cargo and passengers, the difference between the full rate and the ballast rate shall be recovered. If the vessel call at the second port also in ballast and pays three-fourths of the additional rate and enters the same or any other port on the same voyage with cargo or passengers, the difference between the full additional rate and three-fourths of it paid at the second port shall be recovered.

NOTE—1. Half the above rate of dues will be charged on any vessel not discharging or taking cargo after 48 hours (as per Section 47 of Act X of 1889).

2. No dues will be charged on any vessel entering or leaving a port within 48 hours without discharging or taking cargo or passenger.

3. No dues will be charged on any vessel which having left a port is compelled to re-enter it by stress of weather or in any case of damage (as per Section 48 of Act X of 1889).

### Explanations.

(a) "*Ship*" means a sailing vessel and "*steamer*" a steam-vessel.

(b) "*Coasting Ship*" or "*Coasting Steamer*" means, respectively, a ship or steamer which at any port discharges cargo exclusively from, or takes in cargo exclusively for, any port in the Island of Ceylon or in any part of India between the westernmost part of Sindh and the south easternmost part of Burma, and "*Coasting Steamer*" includes a coasting steam-vessel having a general pass under Section 164 of the Sea Customs Act, 1878.

(c) "*Foreign Ship*" or foreign steamer means, respectively, a ship or steamer not being a coasting ship or coasting steamer.

Provided that, for the purpose of the levy of port dues, a vessel shall not be deemed, during one and the same voyage, to be both a coasting ship or steamer and a foreign ship or steamer, but port dues shall in respect of such voyage be leviable on such vessels either as a coasting or as a foreign ship or steamer, whichever rate is the higher.

Cochin Light House	... S. 45° E.

2. Mariners are cautioned that the mud flats off Narrakal have extended Sea-ward.

3. The Mallipuram light, bright, fixed, will be exhibited from the flagstaff from 15th May to 30th September.

4. In taking up an anchorage due consideration should be given to the state of the weather. The anchorage given is a good one for all weathers, but smoother water will be found still further north. Vessels wishing for a quick despatch may, during fine weather, approach nearer Cochin to enable boats to get to and from Cochin between Vypeen Point and the sands, but in this position during a fresh breeze a short sea soon gets up making shipping operation difficult and causing damage to boats.

## Introduction of a Telephone System.

From R. W. HODGES, ESQ., ASST. SUPERINTENDENT OF TELEGRAPHS,  
COCHIN, to CHAMBER, *dated 11th August, 1904.*

In continuation of our conversation on the matter, I have the honor to inform you that there is a proposal to start a Telephone Exchange system in Cochin for the use of the European Firms, and any private persons who may care to join, and I would enquire if you desire to become a subscriber.

2. It is proposed to have the Exchange in the Government Telegraph Office and worked by the Telegraph Department, unless the majority of the subscribers should desire otherwise. In the former case the Telegraph Department would arrange for the Staff and bear the cost of working it; in the latter, the subscribers would have to arrange for their own Staff and would bear the cost of the same in addition to the annual rent charged for their connection or connections.

3. I regret I am not in a position to state the exact amount of rent which would be charged per annum for each connection, for the reason that, where the number of connections to an Exchange are less than 20, the annual rent per connection is fixed in each case by the Director-General of Telegraphs on application to him, but I do not think it is likely to be more than Rs. 150 per annum for an eight hours' service, and probably will be less, but depends on the number of subscribers. In the event of the subscribers electing to work the Exchange themselves the annual rent per connection is Rs.100.

4. The above rent includes Exchange operations (when the Exchange is worked by the Telegraph Department) rent and maintenance of Telephone Transmitter and Receiver, indicator and line not exceeding two miles in length. Each connection is put up by the Telegraph Department at their own cost and the subscriber is only charged the annual rent for the same which covers fare, wear, tear, of instruments.

5. The above rent is for each connection to the Exchange. In the event, however, of a subscriber desiring to have, say his house connected to his office and his office to the Exchange, the above rent will be charged only for the connection from the subscribers' office to the Exchange, the connection between the office and the house involving extra instruments, and line will be charged for extra. The extra rent being Rs.75. per annum provided the length of the line is not over half a mile. If over half a mile an additional Rs.20 per annum is charged for each extra half mile or fraction thereof.

6. In case you should not desire to be connected to the Exchange, but to have a direct connection between say your house and your office, the annual rent charged for the same would be as under:—

For each telephone receiver and transmitter including bell ...	Rs. 45   0   8
For each half mile of line or fraction thereof .....	Rs. 20   0   0

So that for a connection between two places half a mile apart the annual rent charged would be Rs.110.



7. No line or connection to an Exchange can be given up without three months' notice or three months' rent in lieu of such notice; or further, if given up within 12 months of its first inauguration, 12 months' rent will be charged.

8. Kindly let me know if you desire to become a subscriber to the proposed Telephone Exchange.

I am directed by the Board of Revenue to request that you will be so good as to favour the Board at a very early date with reply to its Proceedings No. 4171-Mis., dated 4th August, 1904, regarding the adoption of a Standard Time for general purposes all over India.

I must apologise for oversight in not having replied ere this to the Boards' Proceedings No. 4171-Mis., giving cover to a note on a proposal for an Indian Standard Time, and have now the honor to state that this Chamber is in full accord with the proposal to fix for use upon all railways and telegraphs on Indian and Burman Standard Time which shall be exactly  $5\frac{1}{2}$  and  $6\frac{1}{2}$  hours, respectively, in advance of Greenwich time, and trust that if adopted, similar standards will be recognised for all general purposes.

### Cochin Harbour Scheme.

---

From MESSRS. PEIRCE LESLIE & CO., LTD., COCHIN, to CHAMBER.,  
dated 12th August, 1904.

With reference to Government's recent decision that no useful purpose will be served by sanctioning the levy of landing and shipping fees for the purpose of raising money to enable a preliminary survey of this Port to be made, our Calicut friends suggest the advisability of pointing out to Government the possibility of an alternative scheme being feasible, viz:—cutting a canal through the Vypeen Island from a point on the seashore, where smooth water may always be relied on under the protection of the Narakal-Mallipuram



Mud Bank, to the Backwater. Such canal to be furnished with a lock to prevent a new opening from the Backwater to the Sea. From the west (sea) end of such canal a passage to be dredged out to where the Steamers at present anchor on the Mud Bank, or as far as may be necessary to enable Steamers to enter it. From the East (backwater) end of such canal a passage to be dredged to the deep water in the backwater.

This scheme is on the assumption that there *is* a point on the Narakal Mallipuram shore which is always protected by the Mud Bank from rough water (a reference to the Cochin Sircars records could possibly settle this question) and that, if so, a passage dredged out to sea could be kept open.

We shall be glad if you will place this suggestion before the next meeting of the Chamber for consideration.

### Proposals to revise the Stamp Duty on Insurance Policies.

From the DEPUTY COLLECTOR, COCHIN, to CHAMBER,  
dated 12th September, 1904.

In enclosing an extract from a letter from the Government of India to the Government of Madras, dealing with proposals to revise the Stamp Duty on Insurance Policies so as to secure greater equality and equity of incidence of tax than prevail under the present *ad valorem* system, I have the honor to request that you will be good enough to favor me with your views on the question raised.

*True Extract.*—The system which the Government of India are now disposed to adopt form the taxation of these documents is outlined below:—

1. The Stamp Duty on Fire Insurance Policies shall be fixed at eight annas when the sum insured is less than Rs.5,000, and at one Rupee when the sum insured is Rs.5,000 or more.

2. A separate duty, exclusive of the receipt stamp duty at present payable, shall be levied upon receipts for premiums or portions of premiums, paid in respect of such policies; but the first premium receipt given after the execution of a policy shall be exempt from this special Stamp Duty. The duty leviable shall be four annas when the sum insured is less than Rs.5,000, and eight annas in all other cases. The duty shall be paid by means of stamps impressed on, or affixed to, the premium receipts.

3. The liability to stamp Fire Insurance Policies and Premium Receipts shall be imposed upon the Insurance Companies.

It will be observed that, under the scheme suggested the incidence of the Stamp Duty at present levied will be materially reduced in practically all cases and that small fixed duty will be substituted for the present *ad valorem* rates. The Government of India are of opinion that under an arrangement such as has been proposed, it is essential to impose the liability for stamping the documents upon the Insurance Companies; and as this liability has already been voluntarily assumed by the Companies in the majority of cases, and as the incidence of the duty will be materially reduced, they consider that no objection can reasonably be taken to the proposal on this account. They



are also of opinion that the scheme now suggested will secure a more equal incidence of the duty than obtains under the existing system. I am to explain that the proposal to stamp Premium Receipts has been made in view of the practical difficulties which apparently exist in securing the return of original policies, on due date, for renewal.

We can see no objection to the proposals made.

### **Erection of a Combustible Shed.**

From C. M. SHERMAN, ESQ., ASSISTANT COMMISSIONER OF SALT, ABKARI  
AND CUSTOMS DEPARTMENT, CALCUTTA, to CHAMBER, dated 28th January, 1905.

I have the honor to inform you that the erection of a special Shed at Cochin for storage of Combustibles has been decided on, but a proper site for same is still under discussion. The Board of Revenue (Separate Revenue) appears to be opposed to the selection of the site on the Boat Hard as the construction of other sheds for ordinary cargo will be eventually built on the same. Three other alternative sites (*viz.*, the foreshore on the beach between the Club and the Light-house (site I), the foreshore on the backwater between Mr. John Grieve's residence and the Municipal Victoria Jetty (site II), and at Vypeen (site III), are under consideration—please *vide* copy of this office No. R. B. R. 726/04, dated 24-12-04, discussing the relative merits of the 3 sites and 3 plans herein enclosed.

I have therefore the honor to request to be favoured with the views of the Chamber as to the merits of the sites selected; and in the event of there being objections to them, I should be obliged, if alternate proposals be suggested.

From CHAMBER, to C. M. SHERMAN, ESQ., ASSISTANT COMMISSIONER  
OF SALT, ABKARI AND CUSTOMS DEPARTMENT, CALCUTTA,  
dated 10th February, 1905.

With reference to your letter of 28th ultimo, informing me of the decision arrived at to erect a special shed at this Port for the storage of Combustibles and handing me papers in connection with the matter, I have the honor to inform you that at a meeting of the Chamber held yesterday the subject was discussed, and of the 3 sites suggested for the construction of the proposed Combustible Shed, the third, or the Vypeen scheme, was unanimously decided upon as the most suitable.



I was, however, directed to point out that this site is selected, not so much on account of its suitability, but rather owing to the insuperable disadvantages which the other two sites offer. It was remarked that the Vypeen site would prove inconvenient to both Merchants and Customs authorities owing to its inaccessibility, except by water, and it was considered most advisable, that if possible, the shed should be erected on the business side of the river. The Chamber, however, is forced to admit that such available and at the same time suitable, sites, *i. e.*, sites possessed of water frontage, practically do not exist, the only land being the Boat Hard. The Chamber note that as regards this last the Board of Revenue have in contemplation the erection of other buildings for ordinary goods, but as it is presumed the contemplated erection of these buildings will only become an accomplished fact in the future, it is suggested that the Combustible Shed, which will not take up much ground space, should be erected on this site at present, and if it is subsequently found that there is not sufficient accommodation for both this and the general Goods Sheds the combustible building converted and replaced by another shed on a site to be subsequently determined.

The Chamber note, in conclusion, that the construction of this Shed has been decided upon, but they would like to record their opinion that the requirements of the Port scarcely call for the expenditure, the trade having so far been conveniently carried out without any building such as that now contemplated.

From the SUPERINTENDENT OF CUSTOMS, COCHIN, to CHAMBER, *dated 20th March, 1905.*

In forwarding herewith a copy of a letter received from one Mr. M. A. Patheria, requesting to be allowed to take copies of Export Manifests, and stating that he has applied to your Chamber for the same, I have the honor to enquire whether his statement is correct in its entirety, and whether your Chamber really objects to granting him the information he seeks.



2. I would bring it to your notice that the information sought by Mr. Patheria is not of a confidential nature, and as matters stand, I shall be forced to grant his application. But the advent of Mr. Patheria might result in bringing to the Custom House several other Merchants and I shall then have to raise the question as to whether any Clerks at all, outside the Chamber of Commerce, are to be allowed to handle Manifests. It is obvious that the Custom House cannot afford to have a number of outside Clerks constantly calling for, and disarranging the files of Vessels' papers.

3. You will see then, that, the different firms represented in your Chamber might themselves suffer by this. At present when a firm wants information outside the Chamber of Commerce Statistics, it sends a Clerk down and gets it. The incursion of a number of Clerks seeking the same information as is already furnished to the Chamber of Commerce might lead to the stoppage of the present arrangement.

I shall therefore be glad to learn definitely whether your Chamber is not willing to co-operate with the Custom House in this matter, and thus relieve the tension of an unnecessarily strained situation.

(TRUE COPY). I have the honor to request you will be good enough to allow my Clerk to take copies of Export Manifest from your office every day or according to your convenience.

To avoid the above inconvenience I have some time back applied to the Chamber of Commerce to supply me with this Monthly Report. Mr. Black, the Secretary, refused, saying that their Report is only intended for members.

With further reference to your <sup>211</sup>/<sub>05</sub> of the 20th March at a meeting of this Chamber held on Friday last, the question of supplying copies of Steamer Manifests to non-members on their application was again fully discussed, and I was instructed to inform you that the Chamber are still of opinion that the Statistics compiled by them at considerable expense and trouble are for private circulation only and that to give the general public access to them, even upon payment, would be undesirable in as much as the money collected by such sales would bear but a small contribution to the cost of the compilation. The Chamber, however, recognise the undesirableness from your point of view of the Custom House records being open to the inspection of any and every Merchant's Clerks, and consequently is willing to make some modification in its decision in order to fall in with your wishes. Accordingly, I am directed to advise you that in future, copies of Steamers' Manifests may be obtained on application upon payment of Rs.2 per Manifest, and the Chamber's Monthly Report may be had for the sum of Rs.6 for a minimum of 6 copies.
